





BC Terms & Conditions

1. Startup Requirement

- A minimum startup amount of \$100 is required to begin participation in any NBG income programs.
- All investments, payments, and withdrawals are only processed in cryptocurrencies.

2. Income Types and Conditions

a) Team Matching Income

- Binary Matching Income is set at 10% on a 1:1 matching ratio (equal volume required on both sides).
- Daily capping limit: Maximum \$100 per day can be earned through Binary Matching Income.
- Forex Trading Education is included with the startup.
- Participants are eligible for a one-time 1-night, 2-day educational trip after startup.

b) Direct Sponsor Income

- You earn 1% Direct Sponsor Income every time your directly referred member tops up their account.
- Additional 1% is earned on every future top-up by that direct referral.

c) Mining (ROI) Income

- Start with a minimum of \$100 investment.

d) Level Income

3. Withdrawal Policies

- Withdrawals are processed only in cryptocurrencies.
- Withdrawal requests must meet the minimum withdrawal amount of \$15.
- Withdrawal option will be only once in a month and the specific time and date will be decided by the company
- A 3 % Service charge will be charged by the ID holder in any kind of transaction of withdrawal by the ID Holder .
- Withdrawal processing time may vary but will generally be within 48–72 hours after the request.

4. Top-Up Rules

- Top-ups must be made in cryptocurrencies.
- Every top-up is treated as a fresh investment and qualifies for Direct Sponsor Income.
- There are no limits on the number of top-ups a participant can make.

5. General Policies

- KYC (Know Your Customer) process must be completed before any withdrawal.
- Risk Disclosure: Forex and cryptocurrency trading involve significant risks. Earnings are not guaranteed and depend on individual performance and market conditions.
- No Refund Policy: Once invested, funds are non-refundable under any circumstances.
- Modification Rights: The company reserves the right to modify plans, rewards, or conditions at its discretion with or without prior notice.
- No ID Transfer or Buying of Selling is Permitted .
- Violations of company rules, fraudulent activity, or unethical behavior can lead to account termination without compensation.
